CUSTOMS MANAGEMENT ACT

(Act 22 of 2011)

Customs Management (Tariff and Classification of Goods) (Amendment) Regulations, 2014

In the exercise of the powers conferred by section 270 of the Customs Management Act, 2011, the Minister of Finance, Trade and Investment hereby makes the following Regulations—

1. These Regulations may be cited as the Customs Management (Tariff and Classification of Goods) (Amendment) Regulations, 2014 and shall come into operation on 1st January 2015.

Citation and commencement

2. The Customs Management (Tariff and Classification of Goods) Regulations, 2014 are hereby amended, as follows—
