

S.I. 14 of 2019**EXCISE TAX ACT***(Cap 264)***Excise Tax (Imposition of Sugar Tax on Drinks)
Regulations, 2019**

In exercise of the powers conferred by Section 22 of the Excise Tax Act, the Minister responsible for Finance, hereby makes the following regulations—

1. These regulations may be cited as the Excise Tax (Imposition of Sugar Tax on Drinks) Regulations, 2019 and shall come into operation on 1st April, 2019.

Citation and
commencement

2.(1) In these regulations, unless the context otherwise requires, sugar shall be identified in accordance with the labelling of food products as required under the Food Act, 2014 (Act 8 of 2014).

Application

(2) These regulations shall not apply to fresh local fruit drinks without any additives and plain milk;

3.(1) For the purpose of these regulations “drinks” include flavoured milk.

(2) All drinks specified in the Schedule below, containing sugar content exceeding 5 grams per 100 ml, shall be subject to a sugar tax of SCR4 per litre.

4. An importer shall, upon importation, submit a declaration containing the sugar content of the drinks as specified under regulation 2.
