**Excise Tax (Amendment of Schedule 1 and 2)
(Amendment) Regulations, 2013**

In exercise of the powers conferred by section 22 of the Excise Tax Act, the Minister of Finance, Trade and Investment hereby makes the following Regulations —

1. These Regulations may be cited as the Excise Tax (Amendment of Schedule 1 and 2) (Amendment) Regulations, 2013. Citation

2. The Excise Tax Act (Amendment of Schedule 1 and 2) Regulations, 2009 are hereby amended by repealing Schedule 1 and substituting therefor the following — Amendment of
