BUSINESS TAX ACT

(Act 28 of 2009)

**Business Tax (Business Tax Return Form) (No. 2) Regulations, 2011**

In exercise of the powers conferred by sections 80 and 57 (2) of the Business Tax Act, the Vice President and Minister of Finance makes the following regulations—

1. These Regulations may be cited as the Business Tax Citation (Business Tax Return Form) (No. 2) Regulations, 2011.

2. The Business Tax Return Form shall be in the Business Tax Return Form following prescribed manner—
