

S.I. 9 of 2025**REVENUE ADMINISTRATION ACT***(Cap. 308)***Revenue Administration (Common Reporting Standards) (Amendment) Regulations, 2025**

In exercise of the powers conferred by section 98A of the Revenue Administration Act Cap.308, the Minister responsible for finance makes the following regulations —

Citation

1. These Regulations may be cited as the Revenue Administration (Common Reporting Standards) (Amendment) Regulations, 2025.

Amendment of Schedules

2. The Revenue Administration (Common Reporting Standards) Regulations, 2005 (SI 1 of 2015 as last amended by SI 74 of 2022) is amended by repealing Schedule 4 and Schedule 5 and substituting them with the following new Schedules, for the calendar year 2022 and 2023 respectively —
