The applicable heading for the eSUN PLA+ filament, eSUN PLA-Matte filament, eSUN TPU-95A filament & eSUN PLA filament is 39.16 and was further classified under 3916.9000- Monofilament of which any cross-sectional dimension exceeds 1mm, of other plastics

39.16 – Monofilament of which any cross-sectional dimension exceeds 1mm, rods, sticks and profile shapes, whether or not surface-worked but not otherwise worked, of plastics.

This heading covers monofilament of which any cross-sectional dimension exceeds 1mm, rods, sticks, and profile shapes. These are obtained in the length in a single operation (generally extrusion), and they have a constant or repetitive cross-section, from one end to the other. Hollow profile shapes have a cross-section different from that of tubes, pipes and hoses of heading 39.17.

  - (c) Where it is revoked or amended provided the revocation or amendment is notified by regulations.
